WELCOME TO THE 2010 POOL SEASON!

Please Note the March 31st Deadline.

Dear Prospective or Returning Summer Member:

We hope to welcome you to the Bannockburn Swimming Pool for the 2010 season. This letter explains how you apply or reapply for a Summer Membership in our pool. Additional information about the pool schedule, pool hours, pool rules, social activities, the swim team, etc. is enclosed.

We cannot, at this time, estimate how many memberships will be available this year for applicants who were not Summer Members previously. We will accept applications from new applicants on a '1st come, 1st served' basis, up to the maximum number of spaces available. The sooner you return your application, the higher the chances are that you can obtain a Summer Membership for 2010. We expect to have all membership decisions completed by mid-May and can notify you as soon as possible thereafter. Normally, your cashed check is your notification that you have been accepted for membership. However, if you wish to be notified, please provide your email address below or provide a self-addressed stamped post card on which the following is written for us to check as appropriate:

TO APPLY for 2010 SUMMER MEMBERSHIP, please mail the completed reply form, the completed and signed membership card, and a check for the 2010 membership dues to the address shown above by **March 31st**. We will only deposit or cash your check if your 2010 membership is assured. *You can complete the membership card at your first visit to the pool.*

If you don't provide a post card or an email address, you will only know that you have been accepted when your check clears. Please don't call the membership chairperson about the status of your application. If we cannot offer you a 2010 membership due to oversubscription, we will return your check or destroy it according to your request on the reply form.

DETERMINING THE NUMBER OF USERS

- All permanent household members who will be using any of the pool's facilities must be counted as members. This includes family members, housekeepers, au pairs or baby-sitters, and full-time summer residents of the household. There must be at least one adult per membership.
- For the 2010 season there will be no charge for **infants** born after 1/1/2010.
- Each membership household must include at least one dues paying adult.
- Non-swimmers who will use pool facilities must be included.
- Parents who alternate taking their children to the pool must both be entered on the membership card and must both be included in the dues calculation even if they do not plan to use the pool facilities at the same time.

MEMBERSHIP CARD

- All household members who will be using any of the pool's facilities - whether as swimmers, observers, caretakers of children, etc. at any time during the pool season - must be included on the membership card.
- Please make any necessary corrections and fill in all the information requested.
- Please indicate the total number of pool users in your household, including nanny etc.
- For club records, only one last name per household will be used. Please circle the one that should be used.
- Print the names (including your own) of each pool user (plus the age if under 18).
- Have each person able to do so sign his or her name. People away at school or elsewhere can sign the card at the pool gate upon their return.
- **NO member of your household can be admitted to the pool unless the completed card has been returned to us for use at the gate.**
